The Pennsylvania Governor's Office of General Counsel (OGC) seeks an attorney to work as an Assistant Counsel in the Department of Banking and Securities (Department), Office of Chief Counsel (OCC). The successful candidate will advise on day-to-day legal issues and represent the Department in litigation matters. The position will be classified as an Attorney 1 or 2. While based in Harrisburg, this position is eligible for a hybrid remote/in-office schedule of three days onsite at the discretion of the General Counsel. This is an excellent opportunity for an attorney interested in developing expertise in the laws and processes applicable to Commonwealth government, as well as in banking and financial services.

The mission of the Department is to regulate financial services, work to ensure consumers and businesses are well-informed about the marketplace and promote the safety and soundness of financial institutions and compliance with statutory requirements that provide protections to Pennsylvania residents.

Day-to-day legal matters for this attorney involve advising the Department on all issues relating to the regulation of financial institutions including depository, non-depository and securities industries. Further focus will be on litigation relating to administrative actions and involves drafting and defending orders to show cause, imposing civil monetary penalties, restitution, and other statutorily permitted sanctions. The attorney will also be expected to represent the Department in administrative hearings before the Department of State and, if needed, the appellate courts. Additionally, the attorney may need to review and respond to records requests and assist in regulatory drafting.

The successful candidate in this position will be able to leverage the wealth of experience and knowledge held by the more seasoned members of the OCC staff. The senior attorneys will serve as mentors, offering guidance, insight, and constructive feedback to help bring this successful candidate up to speed on navigating the complexities of this legal practice. The successful candidate will have an opportunity to develop essential skills, gain a deeper understanding of legal nuances specific to the Department, and build a foundation for legal success.
