## SUPERVISORY COUNSEL (Attorney 3 or Attorney 4)

## NORTHWEST OFFICE OF CHIEF COUNSEL DEPARTMENT OF ENVIRONMENTAL PROTECTION (Meadville)

The Pennsylvania Department of Environmental Protection (DEP) Office of Chief Counsel seeks a licensed attorney to work as a Supervisory Counsel in the DEP Office of Chief Counsel's Northwest Regional Office (NWOCC). This position is based in Meadville and will be classified as either an Attorney 3 Supervisory or an Attorney 4 Supervisory depending on the level of relevant experience possessed by the successful applicant.

DEP's Northwest Region is responsible for the Commonwealth's environmental oversight and administration of both state and federal environmental laws in northwest Pennsylvania. The NWOCC is an office of 6 staff attorneys, 2 Supervisory Attorneys, a Regional Counsel, and two support staff. Attorneys within this office provide counseling and litigation services for DEP's environmental programs, including Clean Water, Waterways and Wetlands, Safe Drinking Water, Environmental Cleanup, Waste Management, Air Quality, Oil and Gas, and Environmental Justice. The attorneys draft, negotiate and litigate enforcement actions arising from violation of Pennsylvania's environmental statutes, review and defend permitting actions, and counsel the regional and district mining clients on legal issues pertaining to program implementation. Trial and appellate litigation generally occurs before the PA Environmental Hearing Board and state or federal courts. Attorneys also review responses generated by the DEP programs for Pennsylvania Right to Know Law requests. The work requires close coordination with DEP's management and technical staff, including geologists, engineers, chemists and biologists.

This supervisory position will be one of two supervisors each involved in directly supervising 3-4 attorneys of varying experience engaged in the work described above while also managing a similar individual caseload. This supervisor will be responsible for ensuring the work product of the attorneys being supervised is complete and meets the standards of the Office of General Counsel (OGC), the Office of Chief Counsel, and DEP. This supervisor will also be responsible for the training and professional development of the attorneys being supervised as well as meeting all administrative requirements, such as the approval of leave and travel. In addition, this supervisor may be asked to fill in for the Regional Counsel when the Regional Counsel is unavailable.

The successful candidate for this position will have demonstrated: (1) leadership and the ability to convey constructive input to less experienced professionals; (2) solid legal research, analysis and reasoning capabilities; (3) superior interpersonal and communication skills, especially oral and written advocacy; and, (4) an ability to identify and resolve complicated and sensitive problems creatively and with professional discretion. Preferred candidates will have seven or more years in practice and at least three years with OGC and possess a substantial knowledge of environmental law and litigation experience, including the presentation of expert witnesses. Excellent interpersonal skills, including the ability to foster trust and respect and to create friendly and collaborative internal working relationships with Commonwealth clients are a must.

In addition to the aforementioned legal experience, the candidate must have a Juris Doctor degree from an ABA-accredited law school and be a member in good standing with the Pennsylvania Bar.
