Holmes, LLC be awarded a contract for legal services as primary counsel, and Sand & Saidel, P.C. be awarded a contract for legal services as conflict counsel. The term of the contracts will be one year with two (2) additional one (1) year renewals. The State System of Higher Education, in consultation with the Office of General Counsel, will allocate the legal services set forth in the resulting contracts among the selected law firms. Due to the urgent need for legal services, the State System of Higher Education is seeking The Law Office of Nathaniel M. Holmes, LLC and Sand & Saidel, P.C. to begin work immediately.
