**PART I.**

This RFP was issued pursuant to Executive Order 2015-2 dated January 20, 2015, and in accordance with Section 518 of the Commonwealth Procurement Code, 62 Pa.C.S. § 518, and Part III Chapter 8 of the Department of General Services (DGS) Procurement Handbook.

The Issuing Office designated to conduct this procurement has completed its evaluation. As further described below, the following law firms are being recommended for award of a legal services contract:

The Perry Law Firm, LLC (Conflict Firm)

This memorandum also documents that all necessary steps were taken in conducting the procurement in accordance with the provisions of the Commonwealth Procurement Code. To the extent that written determinations are required under the Code for any of the following steps and no attached record exists, this memorandum shall serve as written confirmation that such step occurred.

**PART II.**

A. PUBLIC NOTICE: Public notice of the RFP was posted on both the DGS website and the Office of General Counsel's website on **July 6, 2016**.

B. EVALUATION COMMITTEE: An evaluation committee was established consisting of agency representatives from the **Pennsylvania Department of Insurance, Department of General Services and the Governor's Office of General Counsel**.

C. ADDENDA TO THE RFP: Potential offerors were given the opportunity in accordance with Section I-9 of the RFP to submit questions concerning the procurement to the Issuing Office. The official responses to the questions were incorporated into the RFP by addenda per Section I-10 of the RFP.

**PART III.**

A. CRITERIA: The relative importance of the major evaluation criteria established prior to opening the proposals consisted of **technical 60%, cost 20%, small diverse business (SDB) participation 20%, and 10 law firm diversity bonus points**.

B. PROPOSALS: A total of **fifteen (15)** proposals were received on or before the due date of **August 2, 2016**. No law firms responded by stating that they would not be submitting proposals. No proposals were received late.

C. RESULTS:

1. The evaluation committee reported the following results of its evaluation to the Issuing Office:
2. As indicated in the Initial Scoring, **two (2)** of the law firm's technical submissions did not receive the minimum **70%** technical threshold and were therefore not considered for purposes of this award.
3. The Issuing Office evaluated and scored the cost proposals and law firm diversity submittals and combined the technical scores, cost scores, law firm diversity scores and the SDB scores received from the DGS Bureau of Diversity, Inclusion and Small Business Opportunities.

Myers, Brier & Kelly, LLP is committed to subcontracting with one (1) small diverse firm, Griesing Law, LLC, for legal services over the entire engagement timeframe. Myers, Brier & Kelly, LLP is committing **25%** of the total value of its offering to **Griesing Law, LLC**

Naulty, Scaricamazza & McDevitt, LLC is committed to subcontracting with one (1) small diverse business, Horizon Healthcare, for legal services over the entire engagement timeframe. Naulty, Scaricamazza & McDevitt is committing **2%** of the total value of its offering to **Horizon Healthcare Consultants**.

O'Brien & Ryan, LLP is committed to subcontracting with one (1) small diverse firm, Strehlow & Associates, Inc., for legal services over the entire engagement timeframe. O'Brien & Ryan, LLP is committing **10%** of the total value of its offering to **Strehlow & Associates, Inc.**

Obermayer Rebmann Maxwell & Hippel, LLP is committed to subcontracting with one (1) small diverse firm, Ahmad Zaffarese, LLC, for legal services over the entire engagement timeframe. Obermayer Rebmann Maxwell & Hippel, LLP is committing **20%** of the total value of its offering to **Ahmad Zaffarese, LLC**.

CONTRACTOR RESPONSIBILITY: Gordon & Rees, LLP, Myers, Brier & Kelly, LLP, Naulty, Scaricamazza & McDevitt, LLC, O'Brien & Ryan, LLP, Obermayer Rebmann Maxwell & Hippel, LLP, Marshall Dennehey Warner Coleman & Goggin, The Perry Law Firm, LLC, and their respective subcontractors required to be disclosed or approved by the Commonwealth have been verified as responsible contractors in accordance with management directives, the Procurement Handbook and the Procurement Code, as applicable.

**PART IV.**

**RECOMMENDATION:** As the Issuing Officer, I recommend Gordon & Rees, LLP, Myers, Brier & Kelly, LLP, Naulty, Scaricamazza & McDevitt, LLC, O'Brien & Ryan, LLP, Obermayer Rebmann Maxwell & Hippel, LLP, Marshall Dennehey Warner Coleman & Goggin and The Perry Law Firm, LLC, be awarded contracts for legal services. This recommendation selection is based upon the results of the evaluation and review of the proposals as summarized above. **The term of the contract will be three years with two (2) additional one (1) year renewals.**



**PART V.**

**CONTRACTING OFFICER DETERMINATION:**

Based upon the results of the evaluation and the above recommendation, I have determined that Gordon & Rees, LLP, Myers, Brier & Kelly, LLP, Naulty, Scaricamazza & McDevitt, LLC, O'Brien & Ryan, LLP, Obermayer Rebmann Maxwell & Hippel, LLP, Marshall Dennehey Warner Coleman & Goggin and The Perry Law Firm, LLC, are the best qualified law firms based on the evaluation factors set forth in the RFP.
